PRESIDENT'S MESSAGE

Fellow members of Probud across the country! As we progress into my second term as national President I find it exciting as more and more I hear about the great service that Probud provides to its members, and many stories are told about renewing acquaintances, finding lost school buddies, going on trips and meeting Probud Members from other countries, making new friends, and on and on. Each time I hear about these experiences I feel so much better ... and more proud.... of our ongoing activities and growth. As I read the copies of the newsletters from various Clubs I am constantly amazed at the variety of programs provided by Clubs, all designed to meet the desires of the local Members, which is really what Probud is all about. It is true that on occasion we have trials and tribulations but overall we are what our Canadian Founder, John Morris wanted us to be ... an organization designed for fellowship and learning opportunities, and I truly believe we are living up to

these objectives..... and my compliments to each and every Club across Canada who have chosen to follow this path.

We continue to grow in numbers and we have now issued 164 charters and have well over 20,000 individual members. Over the past two years we have been involved in a "New Club Development Campaign" and although we did not meet a very optimistic target of 50 new Clubs over the 24 month period we did charter 29 new Clubs and I express my sincere appreciation to all Clubs who developed one or more new Clubs in their community during this period, either independently or with support from their Rotary Club or another Probud Club. In the weeks ahead you will receive more news about the results of the campaign which officially ended on August 31st. Needless to say there are still a number of new Clubs under development and I and your Board of Directors and staff are ready and willing to assist whenever and wherever they can.

As I know you are aware, Probud Clubs across the country are being invited to attend at the first ever Probud Canada "RENDEZVOUS" in September, 2005 to be hosted by the Probud Clubs in the Muskoka area of Ontario. I know that the interest in this event is strong and is growing as the time draws nearer for the actual happening. Your Probud Newsletter as well as a number of mailings from the Organizing Committee have told the story of what will be happening and more details are yet to come but I can assure you of this it is going to happen it is going to be a great opportunity for fellowship and fun and each Club should have the dates of September 27th thru the 30th, 2005 marked on their calendars and watch for the registration opportunity in the months ahead I urge you - do not miss it !

Entering into the fall activities of Probud also means that it is nearing time for renewal of memberships in your Clubs and also renewal of Club memberships in Probud Centre-Canada, Inc. Enclosed with this newsletter you will find the appropriate documentation which I ask you to peruse and give your serious consideration. The annual dues to Probud Centre still remain the same as they have been for several years now, thanks to the diligence of your national Board of Directors \$1.00 per Club Member for annual dues and \$0.25 per member for support of our national web site. There is also the opportunity to purchase Liability Insurance coverage for your Club and your individual Members at a rate of \$1.25 per member per year which protects you in the event that some incident should happen which might lead to some party taking action against you as a Club or as an individual member. On the insurance form there is an explanation of the type of coverage offered and I stress to you that, although we recommend strongly that you have liability coverage, it is not compulsory that you purchase it under the umbrella policy we offer. Any Club is free to contact their insurance company or agent of choice, but we do find that the rate we offer, because of our large numbers, is very competitive. You will also note a new deadline for returning your information and payments which has been changed from October 31st to November 30th as your Board has extended the insurance policy to December 31st to co-incide with the calendar year used for membership dues. I hope we'll hear from you promptly as in the past.

I close this message with a thought ... " I sincerely hope you are enjoying your membership in Probud as much as I am !!

PROBUS CANADA LIABILITY INSURANCE

In the last newsletter it was reported that your national Board of Directors had applied to the insurance carrier to change the name of the policy holder to read "**Probud Centre-Canada, Inc. and Probud Clubs in Canada and Probud Members and Volunteers**". Your Board has been advised that this change has indeed taken place and when you renew your coverage you will note this change on your renewal certificate. This should alleviate any doubt as to who is covered under the liability policy. Please read the insurance form included with this newsletter to better understand why we recommend that you carry liability insurance. It is your choice as to whether you participate in the policy offered but whatever you choose to do, please do not do without . We also ask that you remember that it is not travel or medical insurance it is designed to protect you and your Club in the event of an incident leading to an action against you.
